Quick and Easy Access to Millions of People

Doing business in Žepče provides export access to markets of almost 600 million customers free of customs duties, due to trade agreements of BiH, while delivery times to main European markets can be calculated in hours/days.

Žepče is located near the vital routes connecting South-east Europe and the Adriatic coast, next to the Pan-European Corridor 5C, the railway Ploče – Sarajevo – Budapest and Zagreb – Belgrade highway (80km).
